Cement with 50 sx class "B" neat (59 cu.ft.). Displace with 4 bbls water. Plug down at 1630 hrs 4-29-94. Circulate 2 bbls cement.

Nipple up BOP. Pressure test to 600 psi - held OK. TIH with 6" bit & pipe.
