AFFIDAVIT OF RESPONSIBILITY  
CONVERSION TO WATER-WELL

Cecil D. Gritz, being first duly sworn according to law, upon his oath deposes and says:

1. That he is Agent of Davis Petroleum Corp.  
(Title) (Operator)  
whose address is 1360 Post Oak Blvd., Ste. 2400, Houston, TX 77056
2. That Davis Petroleum Corp. is the operator of a well drilled on land be-

longing to Albuquerque Academy, whose address is 6400 Wyoming Blvd., NE  
(Landowner)  
Albuquerque, NM 87109, said well being drilled to test for hydrocarbons and/or  
carbon dioxide gas and described as the Tamara No. 1-Y, being located 825  
feet from the south line and 857 feet from the east line of Section 3,  
Township 13N, Range 2E, NMPM, Sandoval  
County, New Mexico.

3. That said well was drilled to a total depth of 8732 feet, and that cas-  
ing has been set and cemented as follows: 20" Conductor @ 40' w/6 yds<sup>3</sup> ready mix.

13 3/8" casing @ 383' KB w/325 sx Lite and 100 sx CLB.

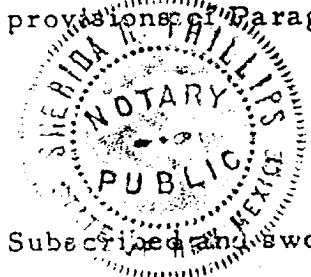
9 5/8" casing @ 1078' KB w/550 sx.

7 " casing @ 6916' KB w/200 sx. Plugged back with 260 sacks.

4. That operator and landowner have made an agreement whereby operator  
(is) ~~(is not)~~ to back fill pits, level location, and clear it of all junk. The agreement  
further provides that operator is to plug said well back to a plugged-back total depth of  
1200 feet and transfer well to landowner for his use as a water-well. Operator will  
leave casing in the well as follows:

5. That when operator has complied with the provisions of Paragraph 4 above  
it will so notify the Oil Conservation Commission of the State of New Mexico on Com-  
mission Form C-103, together with a signed statement from the landowner that the  
provisions of Paragraph 4 above have been complied with to his satisfaction.

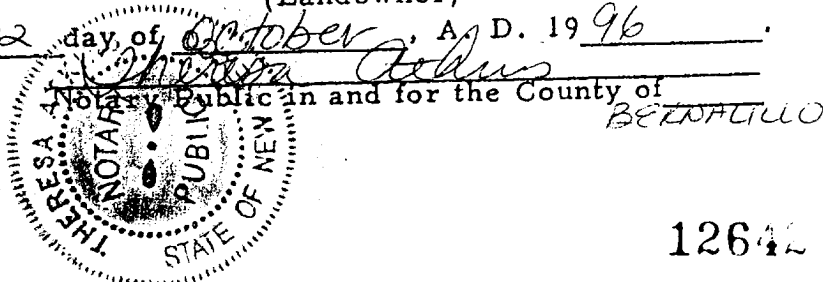
