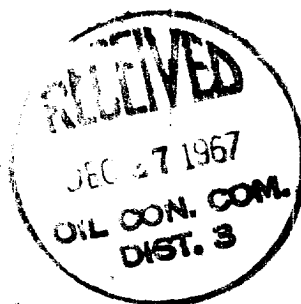

October 18, 1965 we spudded in on the Ann # 10. This well was drilled with a rotary to a total depth of 450'. Shows of oil were encountered in the following sands: 370-395.

Casing was set and cemented (circulated to surface). The well was perforated from 369 to 379 after consulting the electric log. We have tried numerous methods of primary completion. It appears that the only way to recover the oil from this formation is to water flood. We are now evaluating the possibility of a pusher type flood. XXXXXX
