The well was left as a water well in 1957. It has since been leaking water and oil. The NMOC is going to plug the well to surface as follows:

- 1) Set a plug from 2605' - 2505' across Point Lookout Perfs with 23sxs of CI'B.
 - 2) Set a cement plug from 1472' - 1372' to cover the Menefee with 46sxs of CI'B.
 - 3) Set a cement plug from 964' - 864' to cover the La Ventura with 46sxs of CI'B.
 - 4) Set a cement plug from 564' - surface to cover the Chacra, surface casing shoe and surface with 175sxs.
- Plugs # 2, 3 & 4 will be set inside & outside the 5 1/2" casing.
