Pulled rods, pump and tubing. Ran Halliburton 5 1/2" OD EZ-SV cement retainer on tubing and set at 3,939' to abandon perforations from 3982-4008' and 4018-4028'. Mixed 150 sacks of Class A cement. Squeezed 140 sacks below retainer. (130 sacks to formation and 10 sacks in casing). Maximum pressure 1500 psi. No squeeze. Closed valve in retainer and pulled stringer out of packer. Dumped 10 sacks of cement on top of plug. Top of cement at 3849'. Shot off 5 1/2" OD casing at 1400' and recovered casing from this depth. Ran tubing to 1450'. Pumped in 75 sacks of Class A cement with plug from 1450' to 1220'. Pulled tubing. Set 10 sack cement plug in top of surface casing. Installed surface marker June 22, 1972. Cleaned location. Abandonment complete.

Instructions
