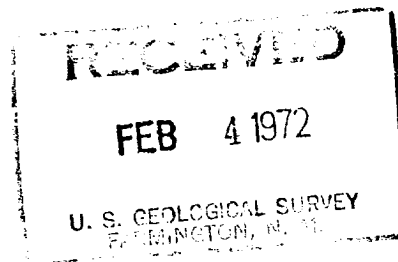

Subject well was drilled to TD at 4790' on 1/19/72. Ran electric logs & DST & decision was made to plug & abandon using the following procedure approved by Mr. McGrath, U.S.G.S., Farmington, New Mexico:

- 1) Fill hole w/ 9.6#/ gal mud laden fluid
- 2) 70 sack cement plug from 4400-4200
- 3) 55 sack cement plug from 3700-3550
- 4) 55 sack cement plug from 2550-2400
- 5) 10 sack cement plug in top of 8 5/8" OD Surface Cong.
- 6) Install dry hole marker & clean location of all debris

Instructions
