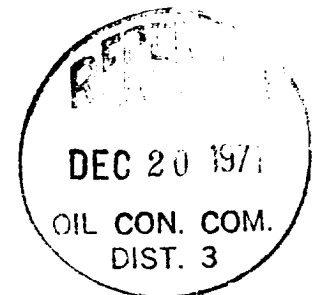

We squeezed perforations at 4652' with 50 sacks cement. Top of cement inside of 5 1/2" at 4500' / 5 1/2" pipe was stuck at 900'. We perforated pipe at 2300' and circulated water in order to free pipe, without success. We perforated 5 1/2" pipe at 2265 to 2269 with sixteen hole and tried circulating pipe free, without success. The well is temporarily abandon, to be permantly plug at a later date.
