Moved in completion unit. Released Baker FH & FHL packers. Tripped out of hole with packers & 163 jts., 3 1/2", 9.3#, J55 plastic lined tubing. Layed packers & tubing down. Picked up Baker 47B-FHL Hydrostatic Retrievable Packer equipped with on/off seal connector with 2.31" "F" profile. Tripped in hole with 112 jts., 4 1/2", 11.60#, K55, R-3 tubing. String landed at 4721' K.B. Packer at 4715' K.B. Installed new tubing head. Displaced 80 bbls. corrosion inhibitor in annulus. Set packer. Nipped up wellhead. Put field back on production. After 36 hours plant injecting 8450 bbls. water/day at 720 psi.
