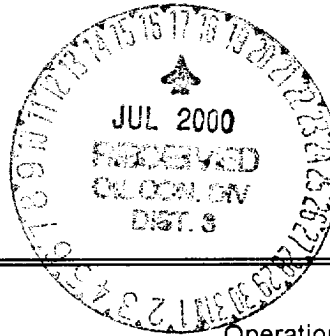

Elm Ridge Resources plans to move a rig into this area sometime in September 2000. This well has a piston stuck in the tubing. We attempted to pull the piston with a slickline unit but could not get the piston out. We will pull tubing, replace bad joints and place well back on production.
