Plan to run IES and CDL logs. If determined productive, will run 4 1/2", 11.6#, J-55 and N-80 casing, selectively perforate, frac, clean out after frac and complete well.

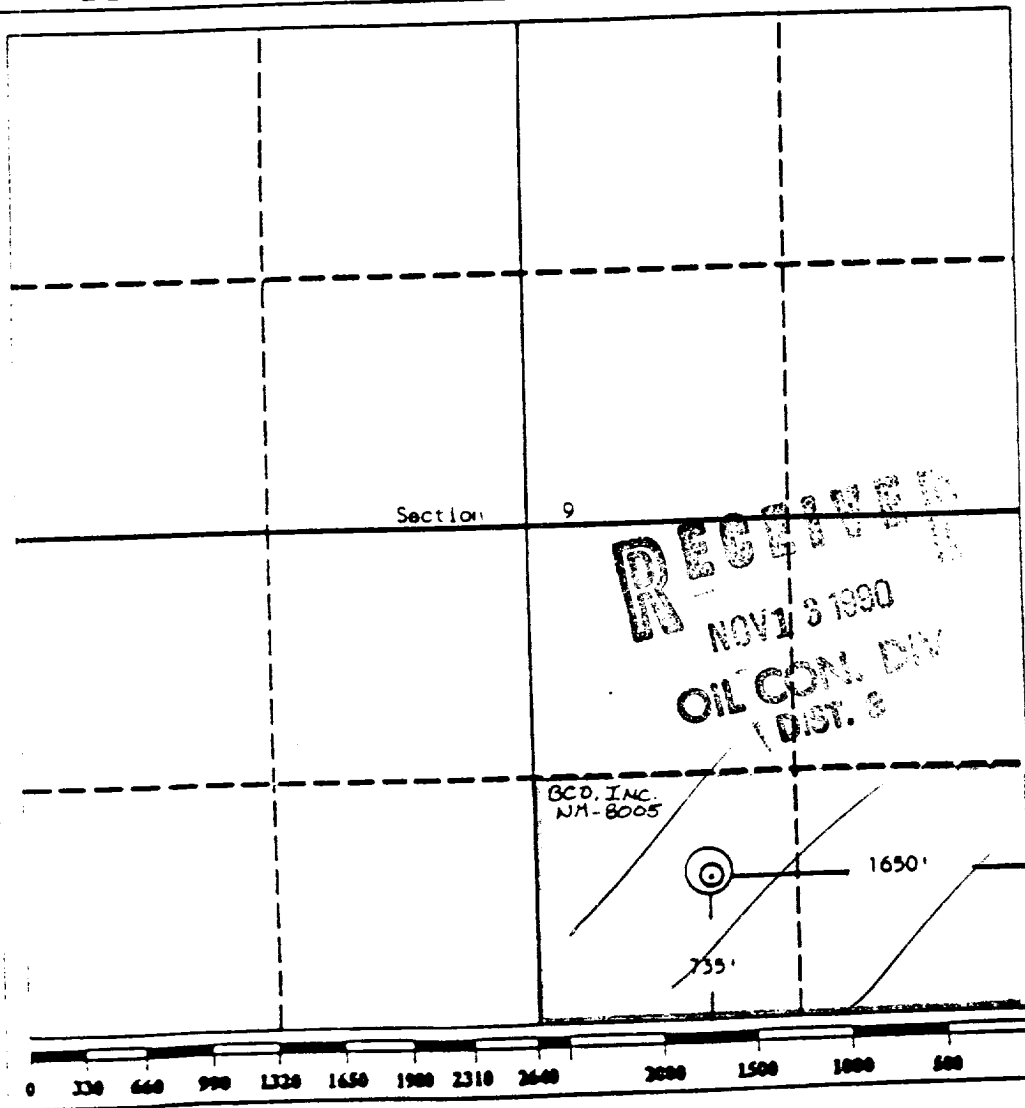
