Cemented with 180 sacks Class "B" cement + 2% CaCl₂ + 1/4#/sx Celloseal (yield 1.18, wt 15.6). PD 11:00 PM 10-2-93. Bumped plug to 600 psi, float did not hold. Circulated 80 sacks to surface. WOC. Drilled out 2:00 PM 10-3-93. WOC 15 hours. Nipped up and tested to 1500 psi for 30 minutes, OK. Reduced hole to 7-7/8" and resumed drilling.
