Run GR/CCL from PBTD (1359') to surface. Perforate Chacra 1142', 50', 57', 66', 74', 84', 93', 1208', 19', 27', 38', 48', 59', 67' (total 14 holes). Acidize with 1,000 gals 15% HCL. Frac Chacra with 153,420# 20/40 sand in 105,550 gals foam. Flow to atmosphere to recover load and test.
