

10-3/4" casing set @ 127', Cement Circulated; (Top of Crt. Plug in 5 1/2" liner Spotted Cement plug in 5 1/2" liner from at 5090')
(5090'-5490') 1/25 Sacks Cement by Halliburton. 5 1/2" liner Perforations from (5722'-7022')
Reamed off 2-ft. of 7-1/8" casing for 37', and recovered 37';
Spotted 35 sack cement plug on top of 7-1/8" stub at 37' to 0' surface.
Installed 4" regulation dry hole marker in top of surface.

Will level location when weather thaws sufficient to do so

Will file final report when levelled.
