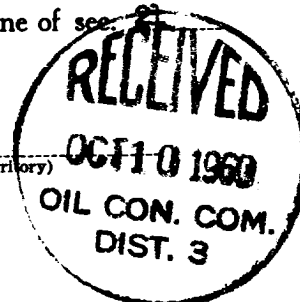

DETAILS OF WORK

Propose to set 8 4/8" casing at 100 feet and cement to surface. Drill 6 3/4" hole to a total depth of 3100 feet where 4 1/2" casing will be set and cemented with 200 sacks of cement. The 4 1/2" casing will be perforated opposite the Pictured Cliffs and treated with water and sand.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

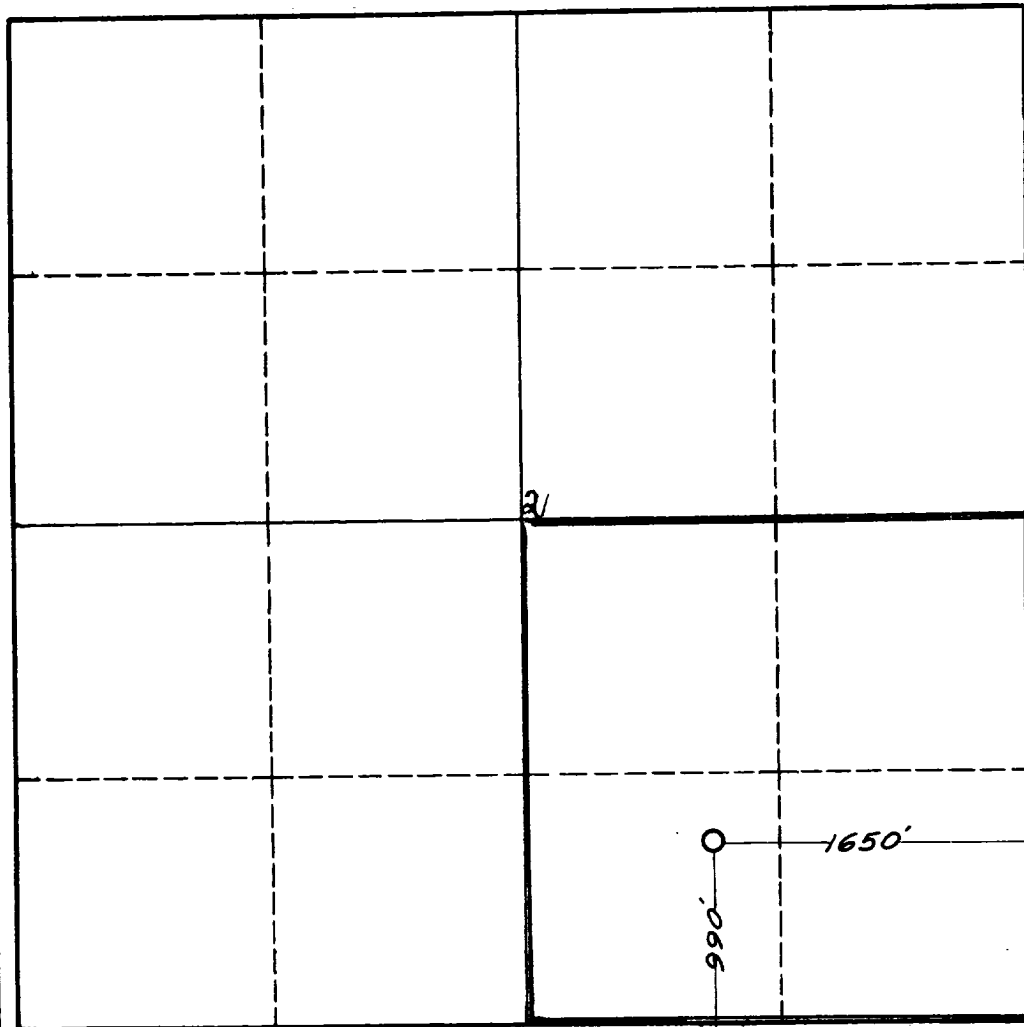
