Gentlemen:

The packer leakage test submitted on your Lybrook #1-19 well in Unit G, Section 19-24N-~~4W~~ on March 7, 1961 indicates that there is a possibility of communication between the Gallup and Dakota producing zones. It is possible that the pressure decrease on the shut in zone on both tests is due to liquid build-up. I am, therefore, directing that this well be re-tested and that the shut-in bottom hole pressures be recorded with a pressure bomb in order to determine if there is leakage.
