1. Spot plug 5500' to 5400'.
2. Spot plug - 50 sx. - 3800' to 3400'.
3. Spot plug 1600' to 1500'.
4. Shot off casing at free point.
5. Spot plug in casing stub.
6. Spot plug in surface casing.
7. Erect dry hole marker and clean up location.

Instructions
