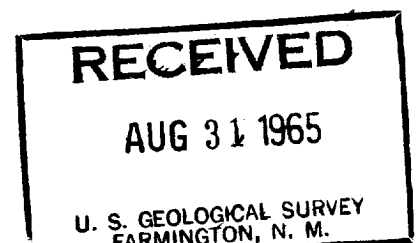

John S. Dashko "B" No. 3 was spudded with 12-1/4" hole 10:30 a.m. August 17, 1965. The 8-5/8" surface casing was set at 372' and cemented with 225 sacks Type "C" cement containing 2% calcium chloride. Cement circulated to surface. The 8-5/8" casing was tested with 1200 psi OK and the hole was reduced to 7-7/8".

Well was drilled to a total depth of 7000' where Induction Electric and Gamma Ray-Acoustic Logs were run.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
