 Drilled out cement and cleaned to PBD.
 Perforated 2310 - 2320, 2326 - 2331, 2344 - 2349, with two holes per foot.
 Sand-water fracked with 14,700 gallons water with 2 1/2#/1000 FR-7 and 2 gal/1000 FS-1 and 20,000# 10-20 sand and 25 ball sealers at 15 BPM and 1800 psi.
 Swabbed well down with very little fluid entry and very little gas.
