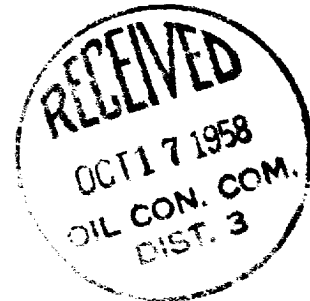

DETAILS OF WORK

It is intended to recover casing and plug this well in the following manner:

1. Recover 1000' 5 1/2", 15.50#, J-55 casing.
2. Plug stub w/100' of cement.
3. Plug surface with 10 sbs. cement.
4. Mark with 4" x 4" diameter post.
