This well logged off with water in January, 1969 and attempts to kick the well off by swabbing have been unsuccessful. Swab testing through tubing and packer located the water entry to be from the point Lookout through perforations from 4637-4722' which were squeezed off during initial completion operations.

Plans are to squeeze off perforations 4637-4722' with 150 sacks of cement.
