Dear Mr. Kleier:

Reference is made to your application dated October 17 and 19, 1990 for a non-standard gas well location for your Jicarilla "B" Well No. 4 located 660 feet from the South and West lines (Unit M) of Section 32, Township 25 North, Range 5 West, NMPM, Basin Dakota Pool, Rio Arriba County, New Mexico. The S/2 of said Section 32 shall be dedicated to the well forming a standard 320-acre gas spacing and proration unit for said pool.

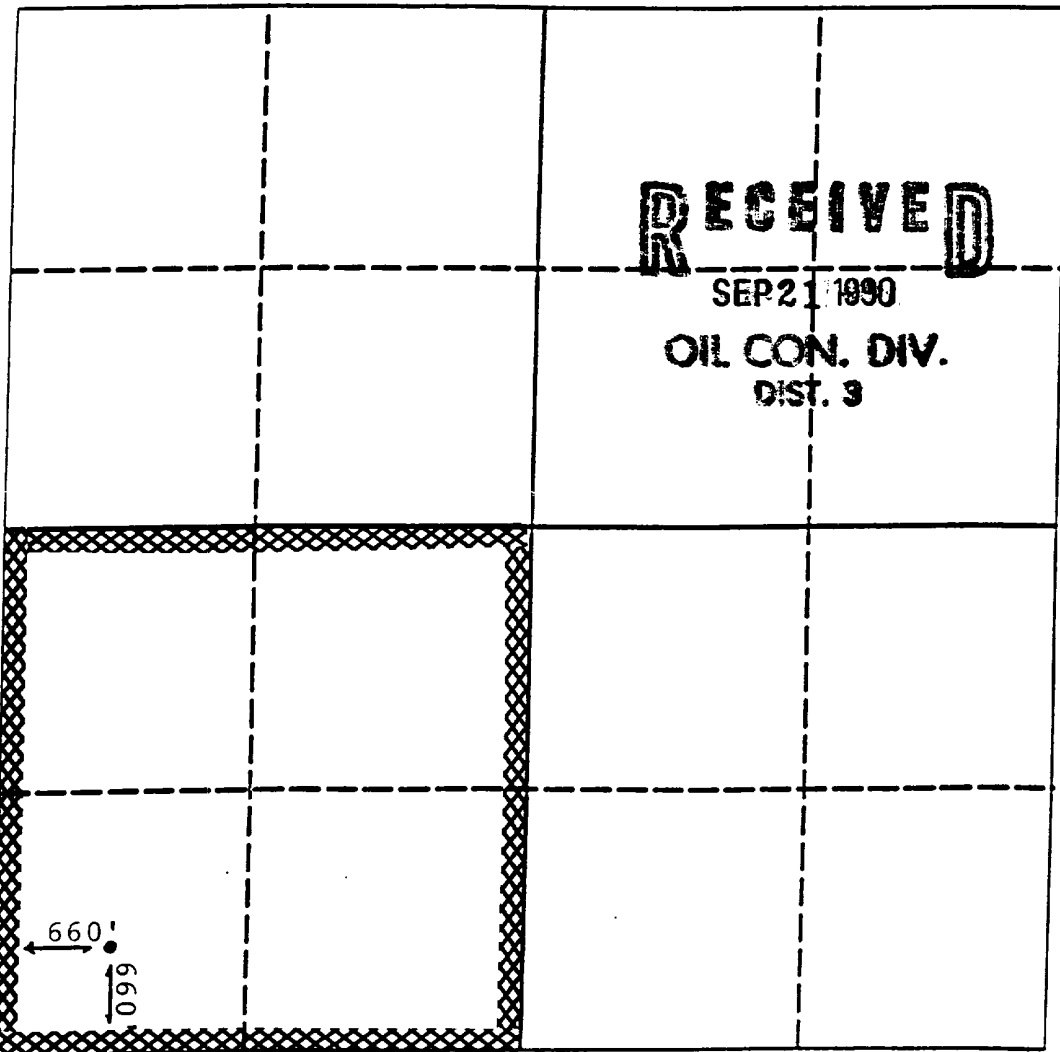
