DETAILS OF WORK

It is our intention to drill well No. 5 to approximately 6200' to test the Gallup formation. Our casing program is as follows:

300' of 10-3/4" OD (32.75%) casing, H-40 - cemented with 250 sks. reg. cement - circulated.

6200' of 5-1/2" OD (15.5%) casing, J-55 - cemented with 450 sks. cement.

The designated drilling unit is the NW 1/4 - SW 1/4 of Section 32-25N-7W, Rio Arriba County, New Mexico.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

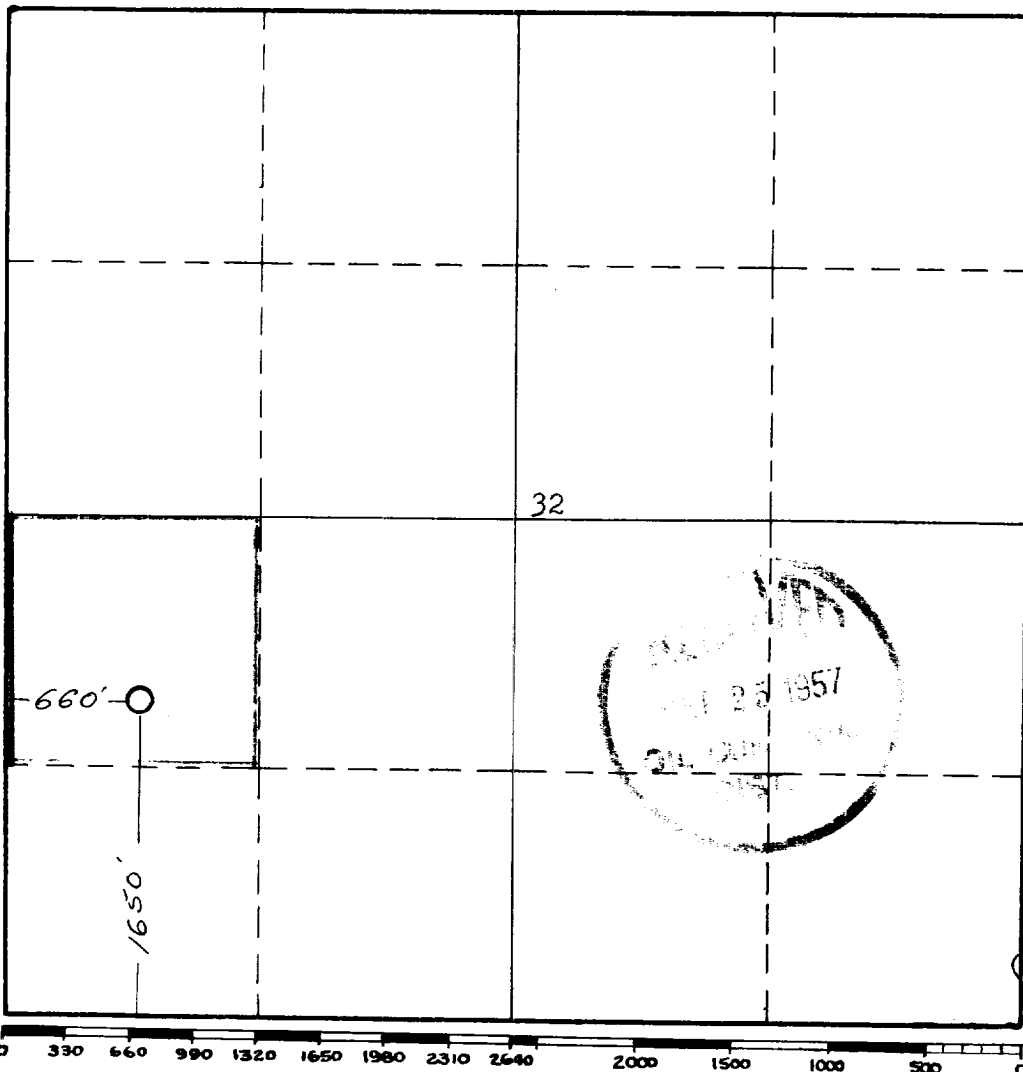
