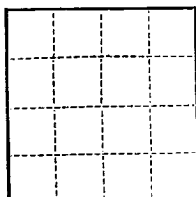

300' of 10-3/4" OD 32.75# N-40 casing with 250 sacks regular cement, to be circulated.

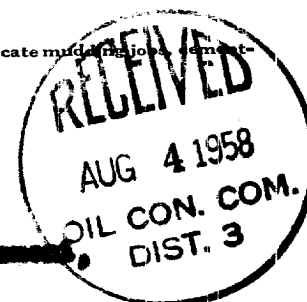
6400' of 5-1/2" OD 15.5# J-55 casing with 450 sacks regular cement.

The designated drilling unit is the NW 1/4-NE 1/4 of Section 32-29N-3W, Rio Arriba County, New Mexico.

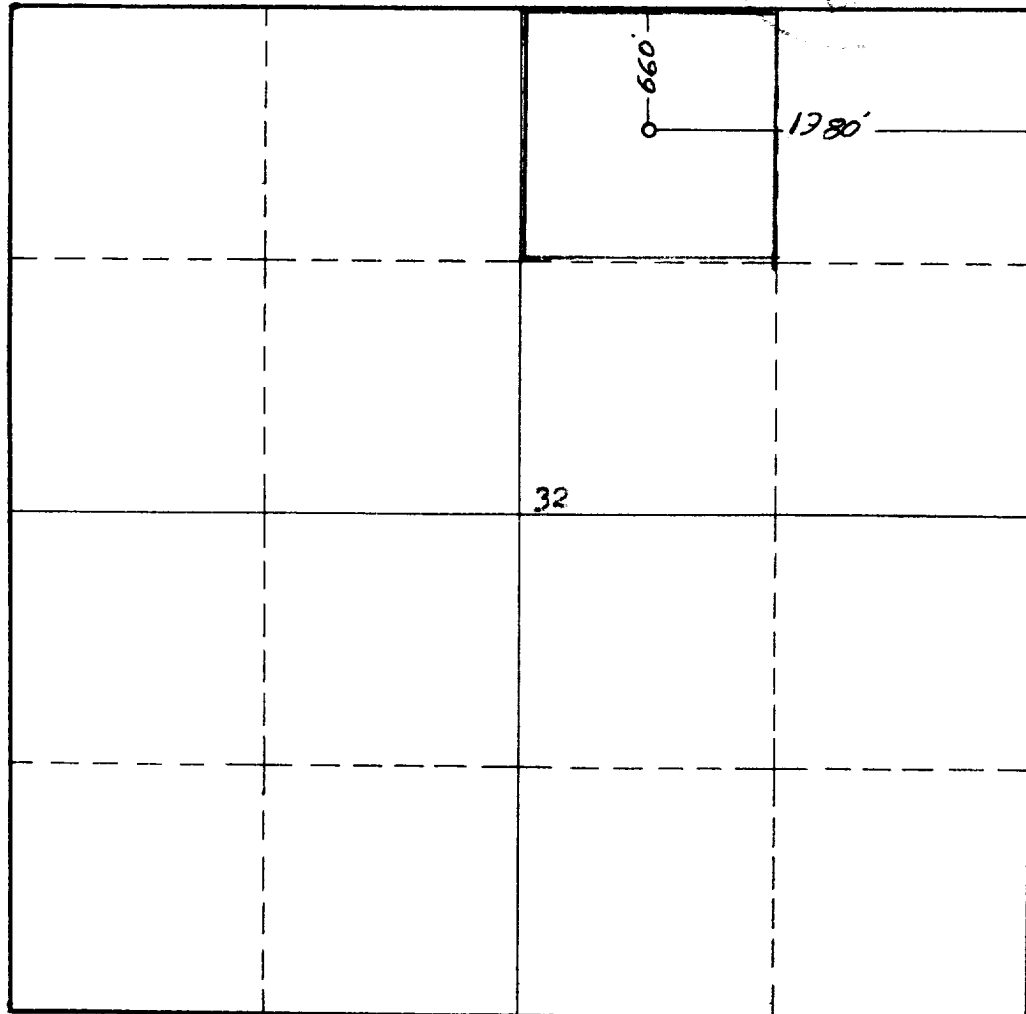
