Drilled hole to total depth of 7712' and ran logs. Set 4-1/2" casing at 7712' with DV tool Set at 5595'. Cemented first stage with 250 sacks Class "A" cement with 50:50 Fox and 6X Gel and tailed in with 75 sacks Class "A" Neat on 8-4-74. Cemented second stage with 1250 sacks Class "A" with 50:50 Fox, 6X Gel and 2 pounds medium Tuf Plug per sack and tailed in with 50 sacks Class "A" Neat cement on 8-5-74. Cement circulated. Tested casing to 1800 psi OK.

Instructions
