Upon completion or abandonment of this well, the location will be cleaned and leveled and a dry hole marker placed, if applicable.

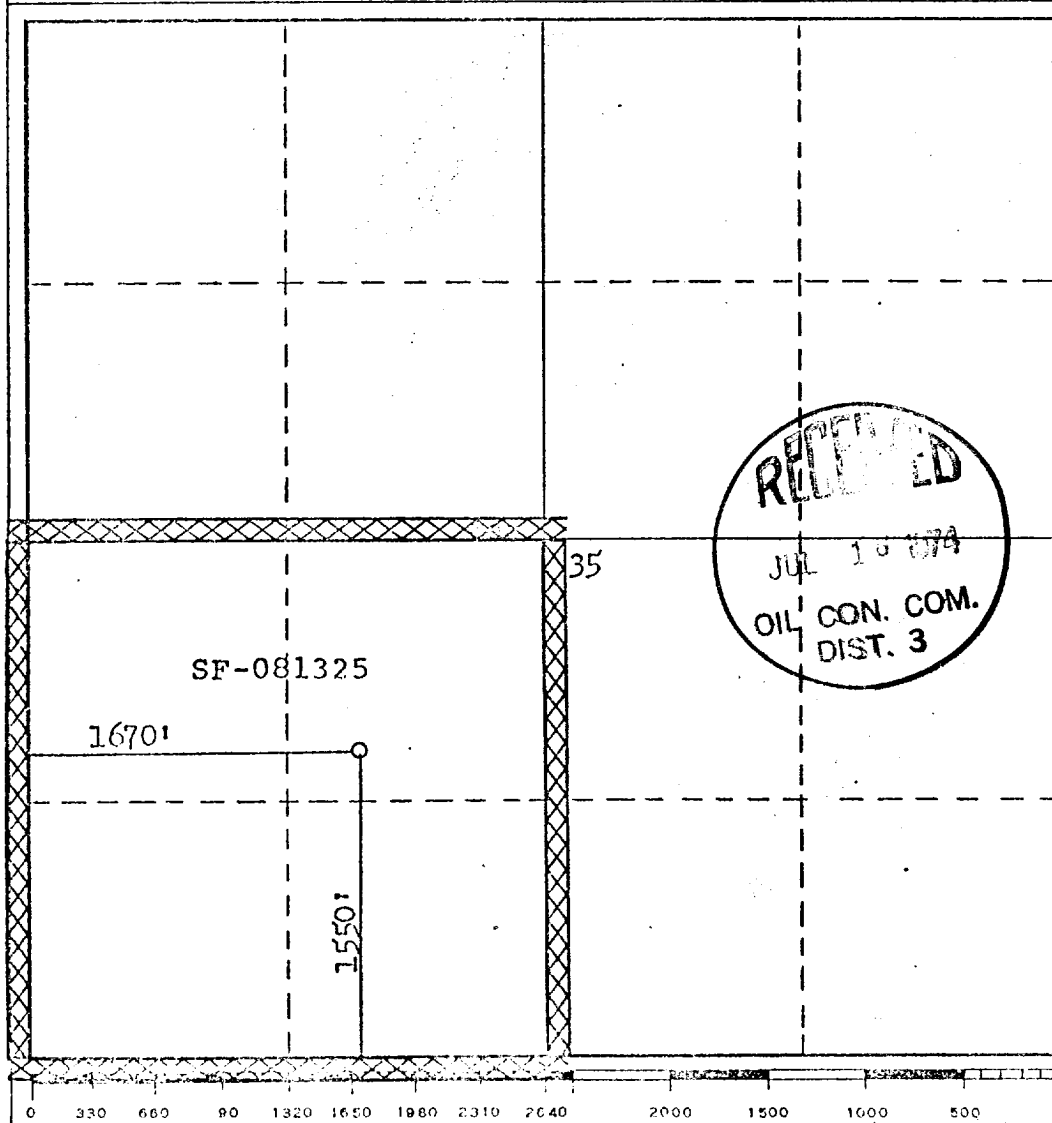

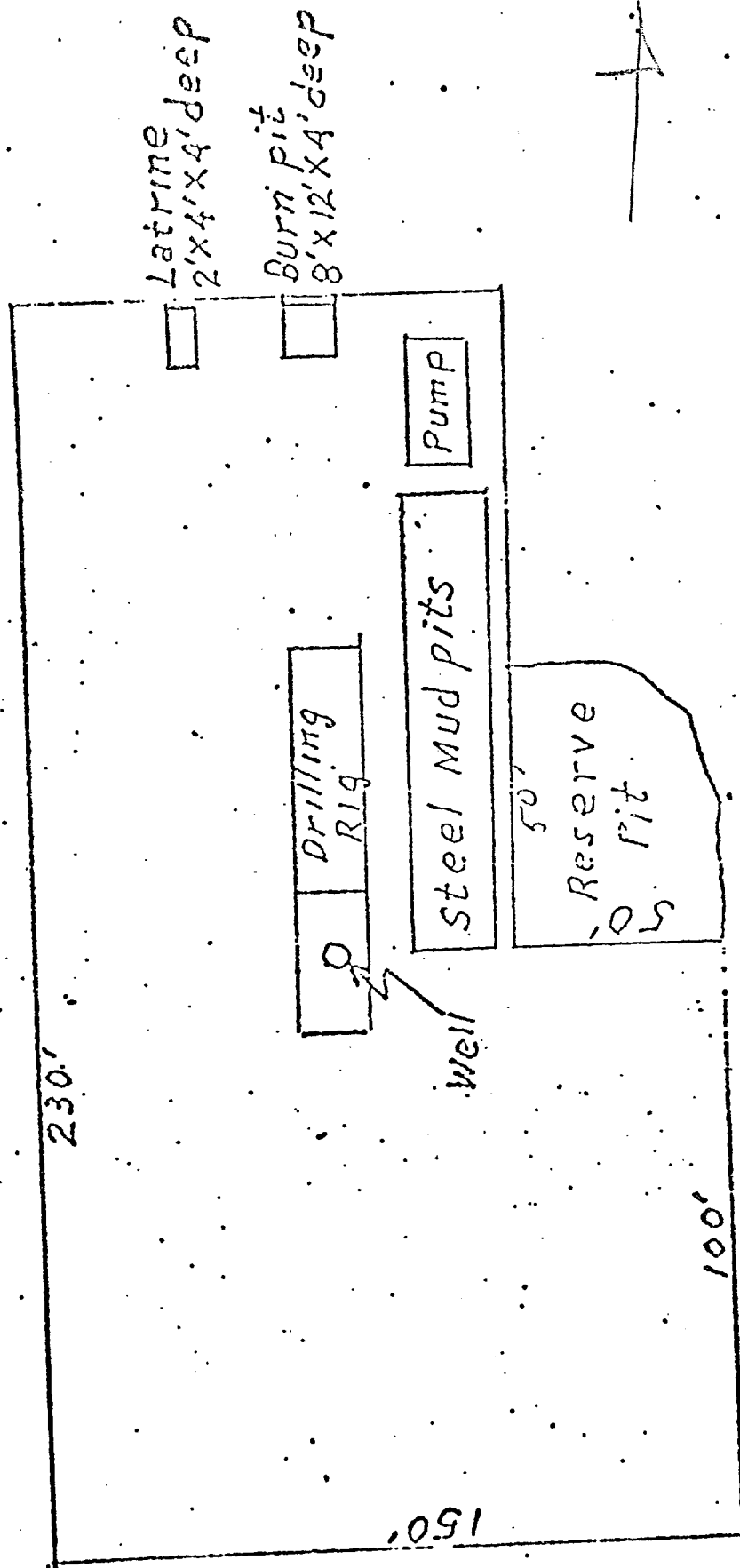

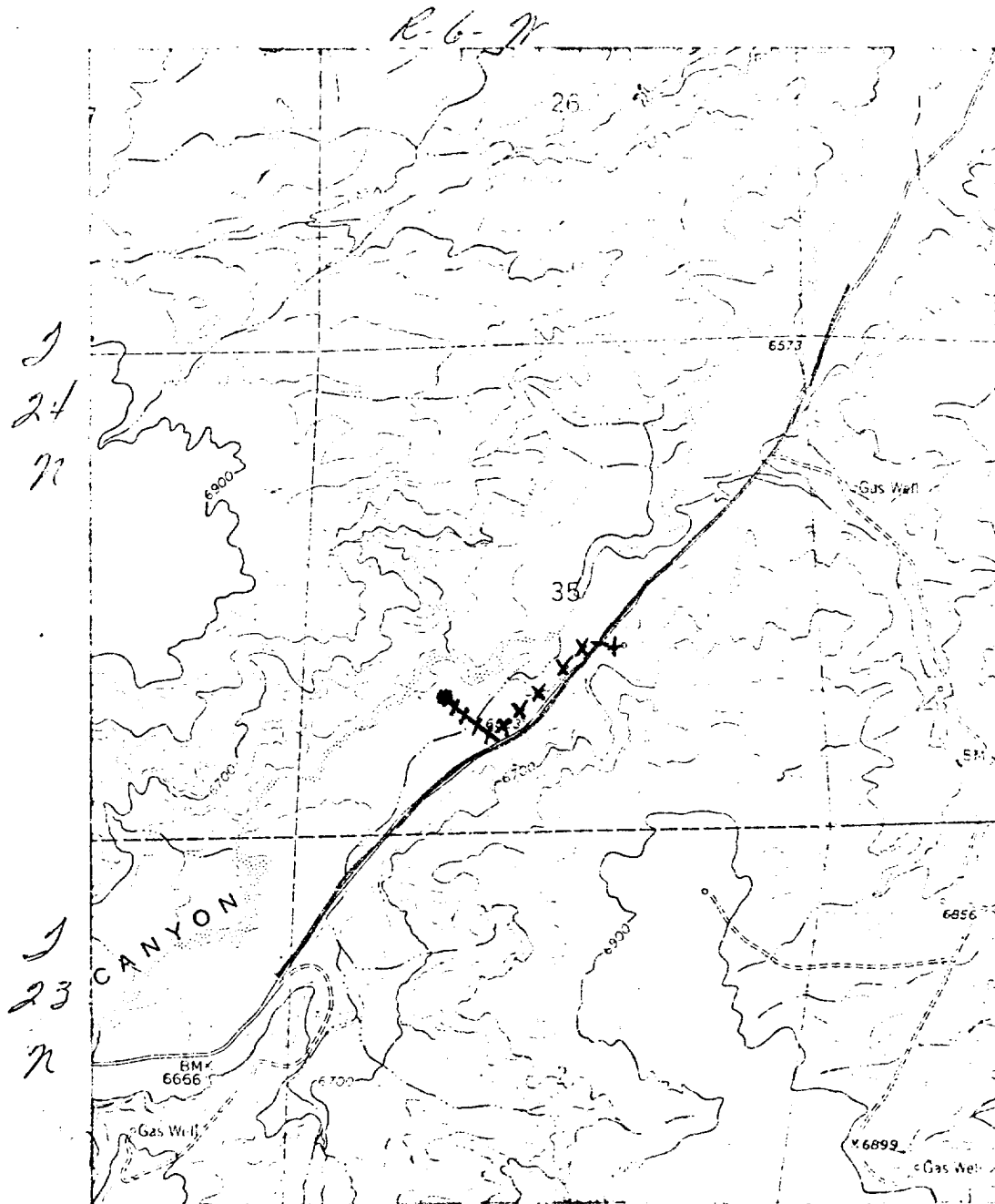
