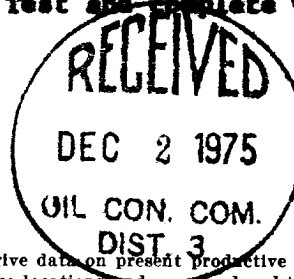

12 1/4"	8 5/8"	24#	100'	100 sxs - circulated
6 3/4"	2 7/8"	6.4#	3200'	200 sxs

Drill 12 1/4" hole to 100 feet, run 8 5/8" surface casing and circulate cement to surface using 100 sacks. Mud drill 6 3/4" hole to 3200 feet and evaluate Pictured Cliffs sand. If warranted, run 2 7/8" casing to 3200 feet and cement with 200 sacks. Perforate and sand water frac Pictured Cliffs. Test and complete well.

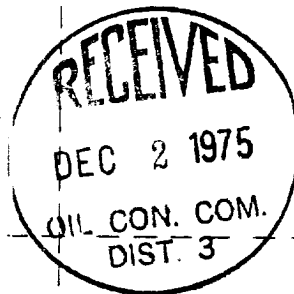
