AMERADA HESS CORPORATION RESPECTFULLY REQUESTS THAT PRODUCTION REQUIREMENTS BE SUSPENDED FOR THE ABOVE WELL UNDER LONG TERM SHUT-IN STATUS FOR ONE YEAR RENEWABLE ANNUALLY OR UNTIL THE WELL CAN BE PRODUCED PROFITABLY. AMERADA HESS RECOMPLETED THE WELLBORE AS A DEMAND WELL IN DECEMBER, 1990 FROM THE BASIN DAKOTA TO THE BALLARD PICTURED CLIFFS FORMATION. SUBSEQUENT TESTING OF THE WELL INDICATED A SHUT-IN TUBING PRESSURE OF 150 PSIG. WHICH IS INSUFFICIENT TO BUCK THE SALES LINE PRESSURE OF 180 PSIG. FUTURE PLANS ARE TO EITHER RE-FRACTURE THE P.C. ZONE, SET A COMPRESSOR TO BULK LINE PRESSURE RECOMPUTE TO GALLUP/DAKOTA.

IN THE INTERIM, AHC WILL TRIP OUT OF HOLE WITH THE TUBING. TRIP IN THE HOLE WITH PACKER AND THE TUBING. AHC WILL SET PACKER AT 2158' (THE TOP PERF IS AT 2181') AND CIRCULATE THE HOLE WITH PACKER FLUID AND TEST TO 500 PSI FOR 30 MINUTES. THIS PROCEDURE SHOULD PUT AHC IN COMPLIANCE WITH ALL RULES AND REGULATIONS REGARDING LONG TERM SHUT-IN.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
