These results suggest a potential mechanism by which a child's reading ability may be related to the quality of the home environment. Children in the high-quality group may have had more opportunities to engage in reading activities with their parents, which could have contributed to their higher reading scores. Conversely, children in the low-quality group may have had fewer opportunities to engage in reading activities, which could have contributed to their lower reading scores.
