13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. This well was drilled and competed in the Pictured Cliffs formation in 1978 and first produced in 1979. It has always been a marginal producer, with a cumulative production of 25,644 MCF. In recent years production has ranged from 2 to 5 MCF/D. The well is no longer capable of producing against line pressure.

Operator is interested in salvaging this well by plugging back and recompleting in the Fruitland coal. Operator believes that the Fruitland coal section is covered with cement, and that the Fruitland coal is capable of production.

Operator has leasehold rights to the NW ¼ and the SE ¼ of Section 14. Operator will need to exchange or acquire leasehold rights in order to put together a 320 acre Fruitland coal unit.

Operator therefore requests an extension until May 1, 2002 to put together a 320 acre Fruitland coal unit, and to submit a detailed proposal regarding said proposed Fruitland coal recompleat.
