It is intended to shut off excessive water production in this well as follows:

1. MIRU. TOH with tubing and packer
2. Set RBP at 5700'. Set packer at 5300'. Squeeze cement Cliff House perms with 100 sx cement. WOC
3. TIH and drill out. Test casing to 500 psi. TOH. TIH and retrieve RBP.
4. TIH and clean out to PBTD. Land tubing at 6150. Return to production.
