Plan to plug and abandon well as follows:

- 1) Spot cement plug from plug back T.D. 3706' - 3554' (100' above perfs).
- 2) Rig up casing jacks and find free point of casing.
- 3) Shoot off casing and spot plug 50' inside casing stub and 50' above casing stub.
- 4) Spot a 100' plug 50' below and 50' inside the surface casing.
- 5) A dry hole marker will then be erected and the location restored.
