THIS WELL IS A SOUTH BLANCO PICTURED CLIFFS AND OTERO CHACRA DUAL COMPLETED WELL. A RECOMPLETE TO THE BASIN FRUITLAND COAL GAS POOL WAS APPROVED 082994. THE VERY LOW PERMABILITY AND LOW PRESSURE IN THE FRUITLAND ARE CAUSING DIFFICULTIES RECOVERY THE WORKOVER FLUIDS. IT IS ESTIMATED THAT IT WOULD TAKE THIRTY DAYS TO SWAB, WHICH IS ECONOMICALLY UNFEASIBLE.

IN ORDER TO TEST THE FRUITLAND RATHER THAN ABANDON, AMOCO REQUESTS APPROVAL TO;

1. TEMPORARILY DOWNHOLE COMMINGLE THE THREE FORMATIONS IN ORDER TO UTILIZE THE ENERGY FROM THE PICTURED CLIFFS AND THE CHACRA TO UNLOAD THE WORKOVER FLUIDS.
2. SELL THE PRODUCTION FROM THE THREE COMMINGLED HORIZONS DURING THE RECOVERY OF THE FLUID.
3. AFTER THE RECOVERY OF THE WORKOVER FLUID, ISOLATE AND TEST THE FRUITLAND SEPERATELY TO DETERMINE IF THIS FORMATION IS ECONOMIC.
4. SELL THE FRUITLAND DURING ITS ISOLATED TEST PERIOD.

IT IS ESTIMATED THAT IT WILL TAKE SIXTY TO NINETY DAYS FOR THE ABOVE.

IF THE FRUITLAND IS ECONOMIC, PERMANENT COMMINGLING APPROVAL WILL BE REQUESTED.

THE OWNERSHIP IN THE THREE FORMATIONS IS THE SAME.
