4-29-82 Finish T.I.H. Washed out 30' of fill-up. Did not drill additional hole. Circ. hole clean. Lay down drill pipe and drill collars. Nipple down B.O.P. Nipple up csg. head. Rig up Fourstates Csg. Service to run csg. Ran 83 jts. 4 1/2", 10.5#, 8Rd, ST&C casing. Set at 3296'. Cement with 75 sx 65-35 poz containing 12% gel and 12 1/2# gilsonite per sk and 1# cello flake per sk. Tail in with 75 sx class "B" neat containing 12 1/2# gilsonite per sk and 1# cello flake per sk. Displace with 52 bbls. fresh water. (Total slurry 320 cu.ft.) Held OK. Set slips and cut off casing. Rig released 2300 hrs 4-28-82.
