**RIO ARriba COUNTY, NM**  
**REPAIR WELL PROCEDURE**

1. TOOH with the 2-1/16" production tbg.
2. TIH with bit and scraper for 5-1/2" csg to 5450'. .
3. Wireline set a CIBP at 5410'.
4. Cap the CIBP with 10' of sand/barite mixture. Bring the mixture up to 5400'. The mixture should be 33% barite and 67% 20/40 sand.
5. TIH with muleshoe, SN, and 2-1/16" tbg and land intake at 5340'.
6. Swab the well in and RTP.
