## AMENDED COMMINGLING ORDER PLC-58

The above-named company is hereby authorized to commingle Otero Gallup, Basin Dakota, and Ballard Pictured Cliffs pool production from the following leases:

Lease Name: Northeast Haynes  
Description: S/2 Sec. 9, S/2 Sec. 10, All Section 15 and 16, N/2 Sec. 21 and N/2 Sec. 22, T-24N, R-5W, NMPM, Rio Arriba County with Basin Dakota production from the following wells in T-24N, R-5W, NMPM, Rio Arriba County:

Northeast Haynes Well No. 1E, SW/4 SE/4 Section 9;  
Northeast Haynes Well No. 2E, SW/4 NE/4 Section 16;  
Northeast Haynes Well No. 3E, NW/4 SW/4 Section 16;  
Northeast Haynes Well No. 4E, NW/4 NE/4 Section 21;  
Northeast Haynes Well No. 6E, NW/4 NE/4 Section 15;  
Northeast Haynes Well No. 7E, NW/4 SE/4 Section 10;  
Northeast Haynes Well No. 8E, NW/4 SW/4 Section 15;

and with Ballard Pictured Cliffs production from the following wells in Township 24 North, Range 5 West, Rio Arriba County, New Mexico.

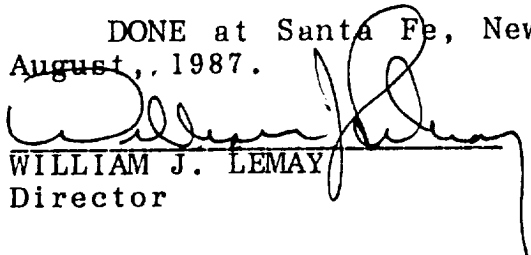
Northeast Haynes Well No. 11Y, SW/4 SW/4 Section 15;  
Northeast Haynes Well No. 12, SW/4 SE/4 Section 16;  
Northeast Haynes Well No. 14, NW/4 NW/4 Section 22;  
Northeast Haynes Well No. 15, NE/4 NE/4 Section 21.

Production shall be allocated to each lease by well tests (if this method or the subtraction method above is to be authorized, all commingled production must be of identical ownership: working interest, royalty interest and over-riding royalty test).

NOTE: This installation shall be installed and operated in accordance with the applicable provisions of Rule 309-B of the Division Rules and Regulations and the Division "Manual for the Installation and Operation of Commingling Facilities." It is the responsibility of the producer to notify the transporter of this commingling authority.

REMARKS: This amendment allows for the addition of well Nos. 11Y, 12, 14 and 15, which are producing from the Ballard Pictured Cliffs Pool.
