RIH w/junk basket to recover balls. Slick water frac perfs down csg. with 42,165# 20/40 sand and 71,446 gallons slick water Pad-flush. Avg. treating pressure = 2325 psig @ 50 BPM avg. treating rate. ISIP = 750 psig. RIH w/tbg. and land @ 5300'. NDBOP. NUWH. Swab and flow well back. Release well service rig on 11/12/01. Shut-in well awaiting pipeline connection.
