Union Texas Petroleum wishes to advise that a 7-7/8" hole was drilled to 5775' KB. 4-1/2", 10.5#, K-55 casing was run to 5775' KB (DV tool at 3409' KB), and cemented to surface as follows: 1st stage - 610 sxs (958 cu.ft.) 50/50 POZ w/4% gel, 6-1/4# gilsonite/sk and 10# salt/sk. 2nd stage - Open DV tool, circulate 17 bbls (95 cu.ft.) of cement to surface. Cement 2nd stage w/400 sxs (1148 cu.ft.) 65/35 POZ containing 12% gel and 12-1/2# gilsonite/sk. Circulate 26 bbls (146 cu.ft.) of cement to surface.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
