Mesa Grande Resources, Inc. is giving notification of first production on the Federal Prowler #2 Well.

We are currently pumping well back @ a ratio of 28 bpd. 57% oil & 43% water (frac fluid). Oil is presently going to permanent storage facilities.

Operator herewith requests permission to vent 18,000 mcf gas for testing of well. An orifice tester will be put on every 2 weeks for gas volume. Production tests are to ~~begin~~ ^{begin} on 12/8/87.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable local, area, or regional procedures and practices, either as shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
