Drilled 6½" hole to 5721. Ran 131 jts. of 4½" 11.6# casing x set at 5718'. Cement with 330 sks. 65/35 poz w/12% gel x 6# per sack gilsonite followed by 250 sks. 50/50 poz w/2% gel x 10% salt. Plug down at 4:00 p.m. 10/31/90. Circulated 40 Bbls. of cement to surface. Tested casing to 1500#.
