Move in & rig up Smith Drilling. Spud 9-1/8" hole at 1330 hrs 10-14-94. Drilled surface - 135'. Circulate hole. TOH with pipe. TIH with 3 jts. 7" 23# N-80 casing landed @ 127'. Cement with 50 sx class "B" neat (59 cu.ft.). Displace with 4 bbls water. Plug down 1700 hrs 10-14-94. Circulate 1 bbl cement. Shut in.

Nipple up BOP. Pressure test to 600 psi - OK.
