Tail in with 60 sx neat w/1/4# celloflake/sk (317 cu.ft.). Displace with 27 bbls water. Plug down at 1200 hrs 4/10/96. Cement pressure 600#. Held OK. Circulate 5 bbls cement. Turbolizers @ 1100' & 1010'.
