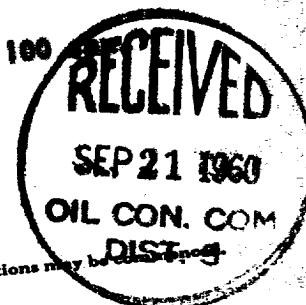

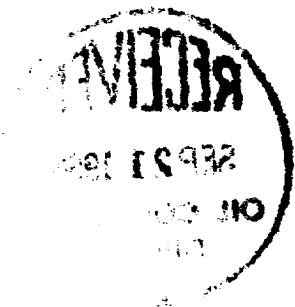
- (1) We propose to cement 200' of 10-3/4" surface casing with 125 sax.
- (2) Drill to 6400' with rotary tools to test Gallup formation.
- (3) Cement 6400' of 5-1/2" casing with 150 sax.
- (4) Set BV tool below Pictured Cliffs formation and cement with 100
- (5) Perforate and sand frac Gallup formation.

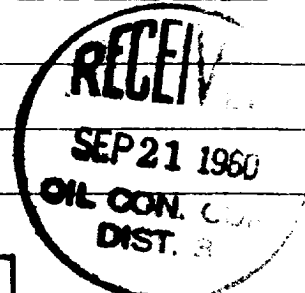
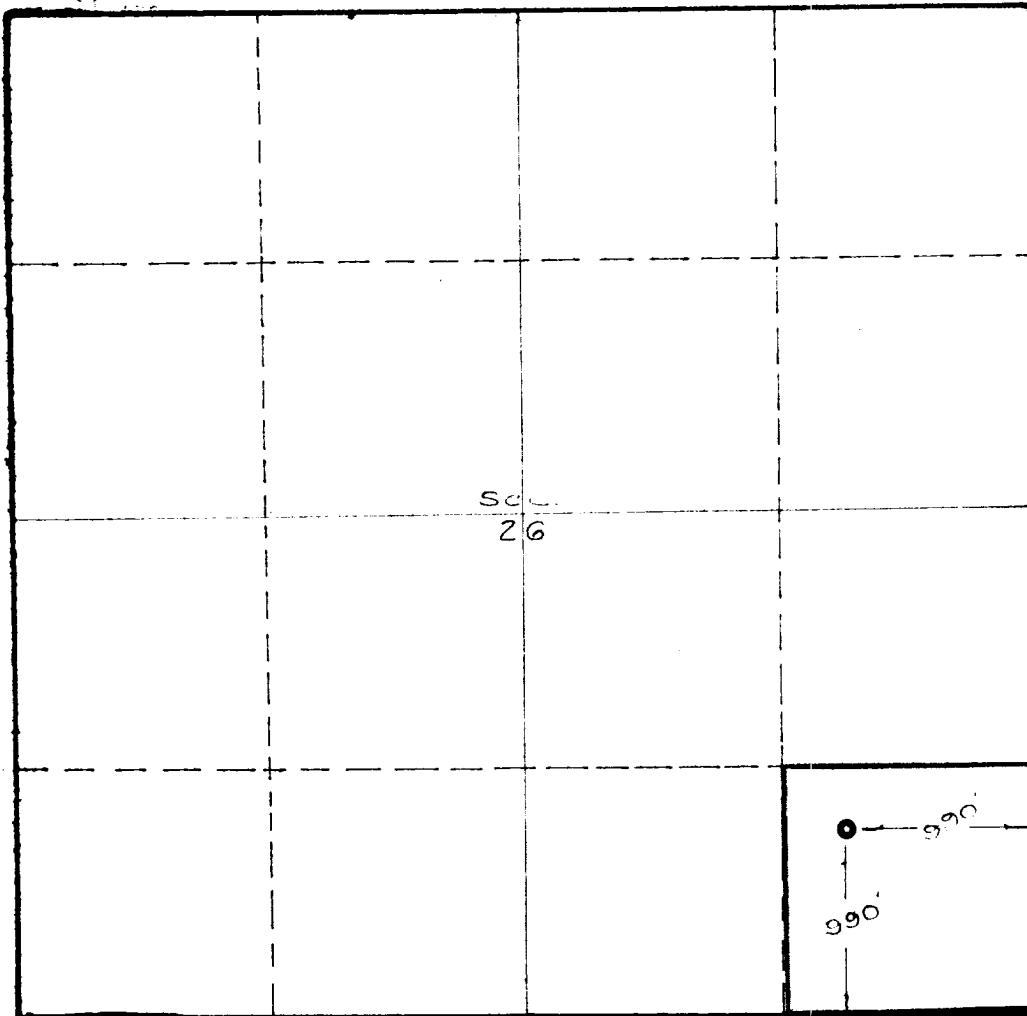
