Dear Mr. Porter:

This is a request for administrative approval for an unorthodox gas well location in the South Blanco Pictured Cliffs pool.

It is intended to locate the well, El Paso Natural Gas Company Vaughn No. 5, 1900 feet from the South line, and 690 feet from the West line of Section 29, Township 26 North, Range 6 West, N.M.P.M., Rio Arriba County, New Mexico.

The SW/4 of Section 29 is dedicated to the well. As shown on the enclosed plat the SW/4 consists of a canyon to the North and rock cliffs to the South. The only accessible land for a well in the SW/4 is that which makes the location unorthodox. It is, therefore, planned to make the location unorthodox in order that the extremely high cost of constructing an orthodox location be avoided.

Since El Paso Natural Gas has control of the offset leases, approval for an unorthodox location has not been sought from other operators.

I am enclosing two copies of the certified well location plat and two copies of the intention to drill.

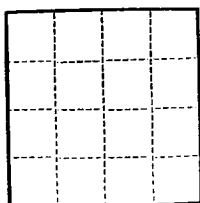

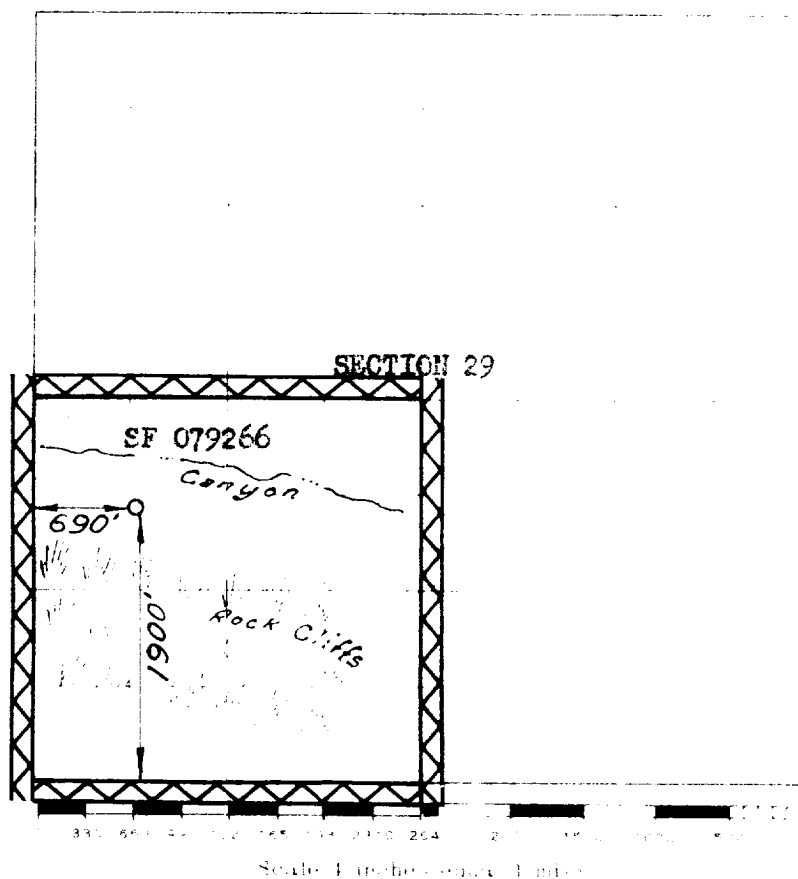
