DETAILS OF WORK

Propose to drill 9-7/8" hole to 125', set 7-5/8" OD casing & cement to surface w/100 sx reg. Drill 6-3/4" hole to total depth of 3340', set 5" OD casing & cement w/100 sx reg. Perforate the 5" casing from 3195 - 3255 & fracture the Pictured Cliffs w/approx. 40,000# gals water using 1# sd/gal. Clean out, hang 1-1/4" OD tubing @ 3245' & complete well. The SW/4 of Sec. 30, containing 161.5 acres, is dedicated to the well.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

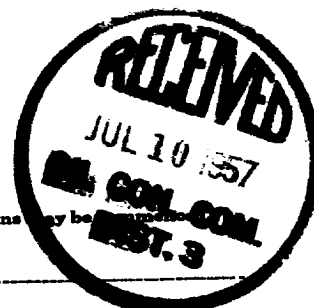

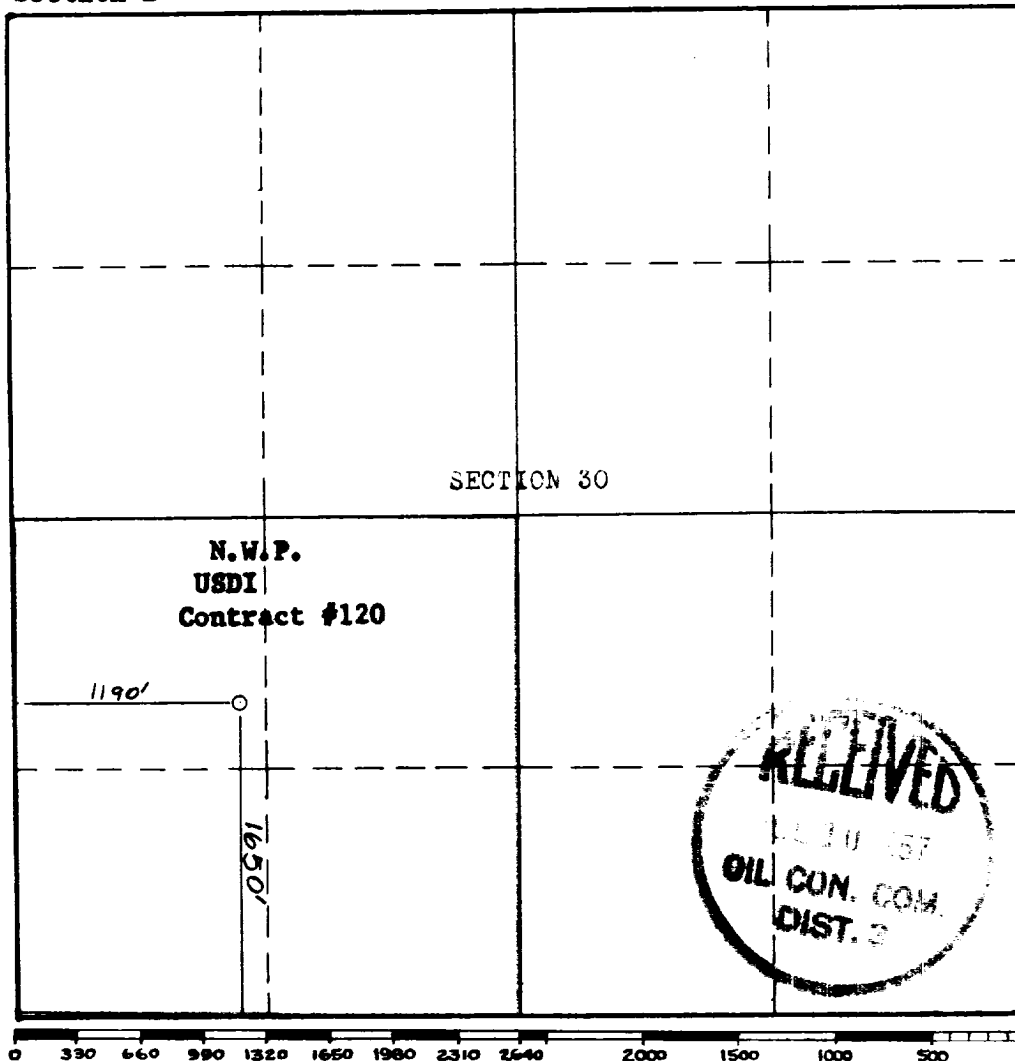
