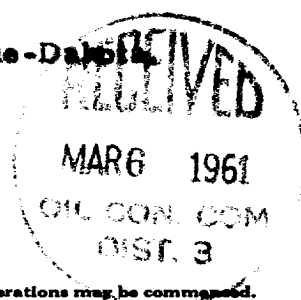

4. Complete as single zone Dakota or dual zone Mesaverde-Dakota.

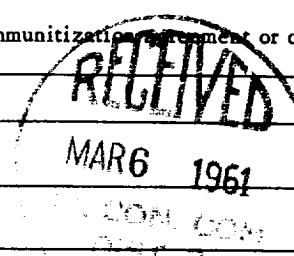

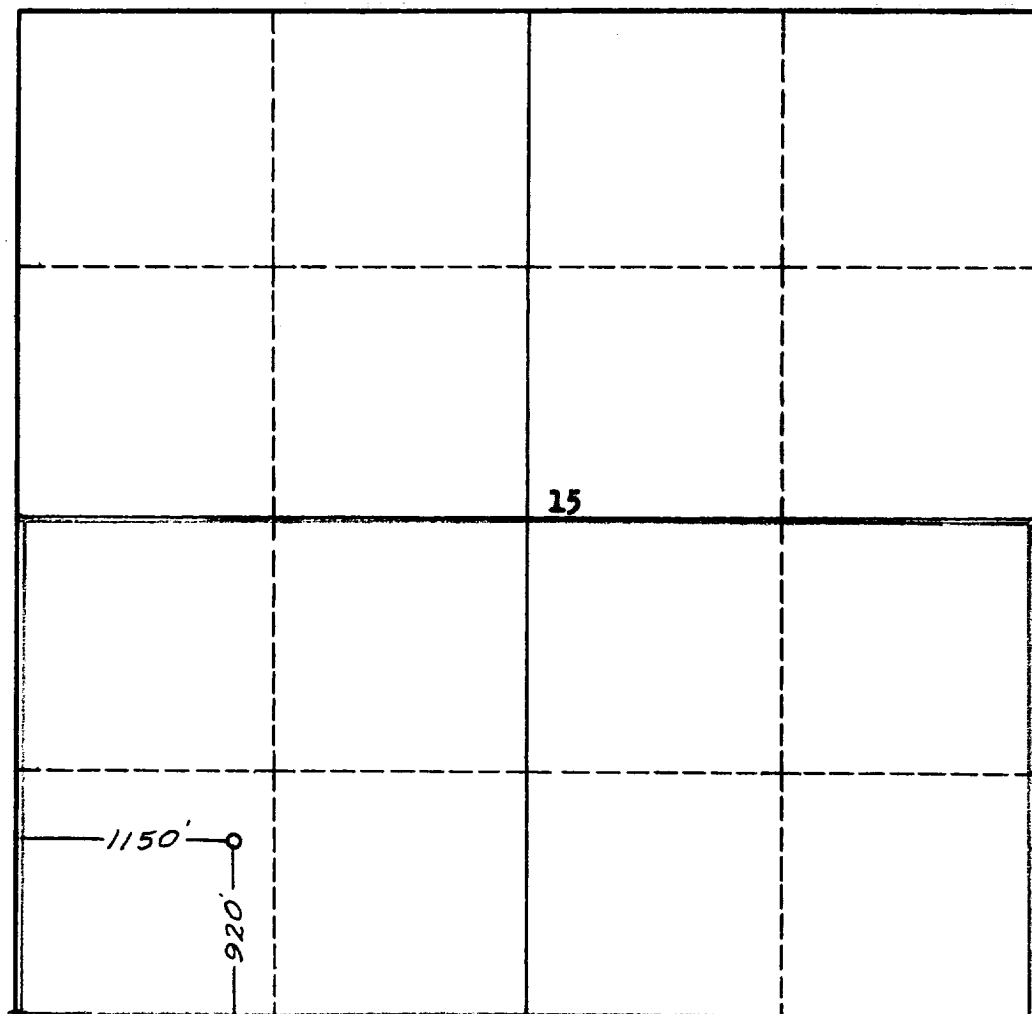
