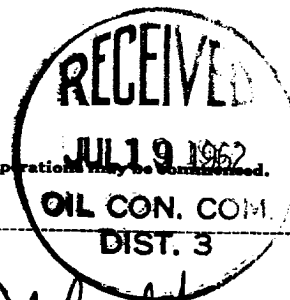
1. We propose to drill and test the Dakota formation. Anticipated at a Total depth of approximately 7915'.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

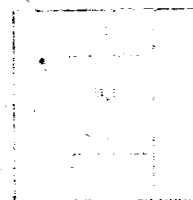
