DETAILS OF WORK

Drill to 300' Run 10 3/4" casing and circulate cement to surfaces. Drill with mud to 4000' and set 7" casing, cement with 200 sx. this thru P.C. Drill with gas through MV to about 6100'. Hang 4 1/2" liner and cement throughout. Selectively perforate and frac PC and MV effecting an approved type dual PC MV completion with packer separation and two tubing strings.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

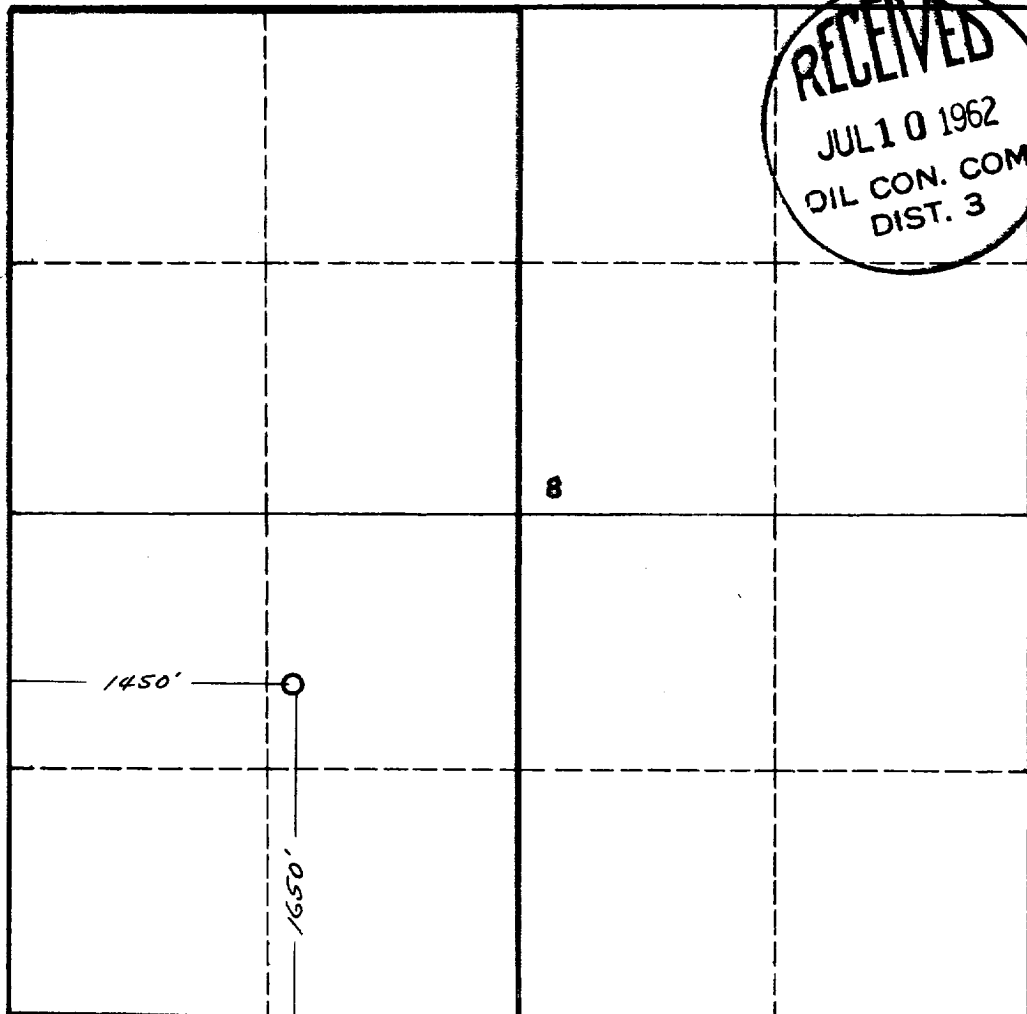

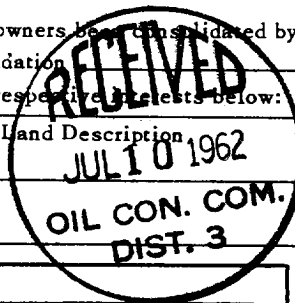

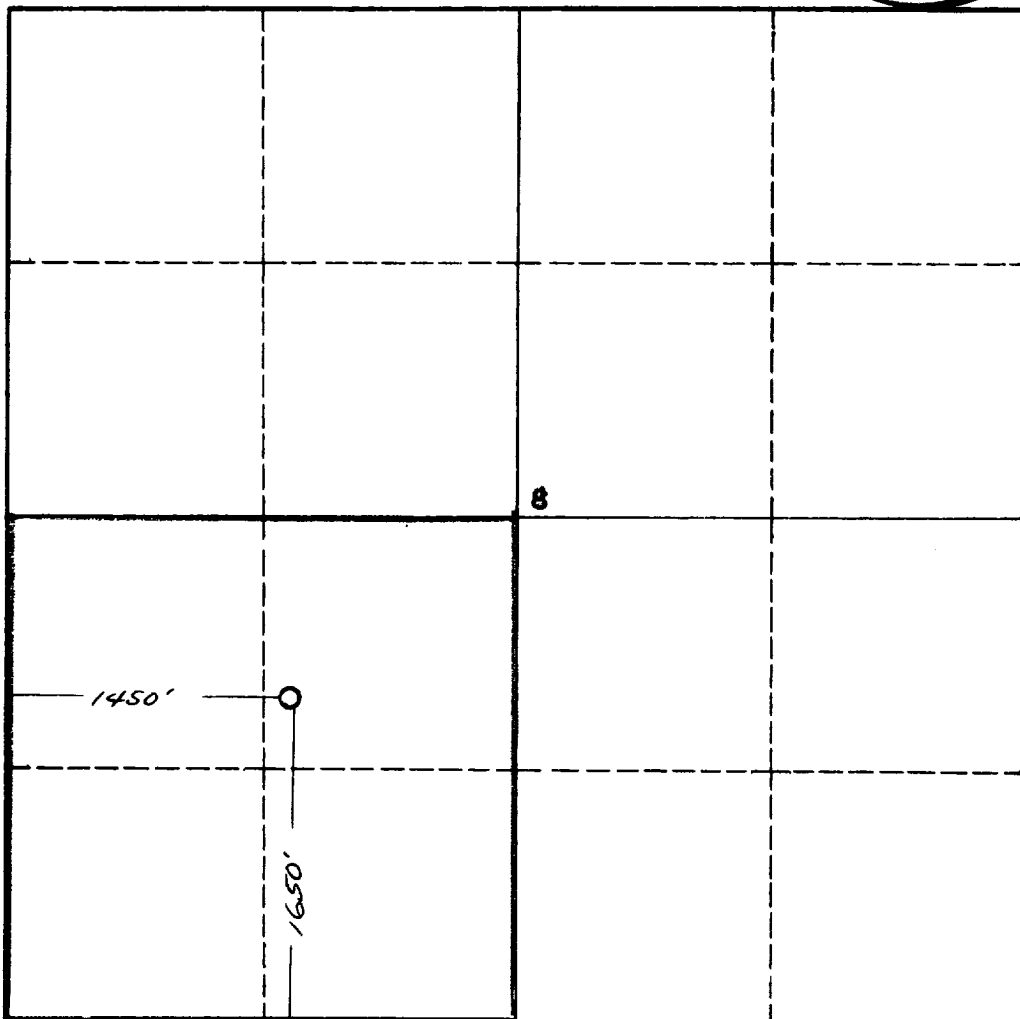
