Plug & Abandonment Report

#### Cementing Summary:

- Plug #1 with CIBP at 3551', spot 97 sxs Class B cement inside casing up to 3119' to isolate PC perforations and to cover up through Ojo Alamo top.
- Plug #2 with 66 sxs Class B cement spotted in casing, then PUH with tubing to 1000' and squeeze 16 sxs cement outside 7-5/8" casing until it pressured up to 1000#; leave 50 sxs inside casing up to 1438' to cover Nacimiento top.
- Plug #3 with 198 sxs Class B cement pumped down 7-5/8" casing from 371' to surface, circulate good cement out bradenhead.

#### Plugging Summary:

Notified BLM and Jicarilla Apache Tribe 8/18/00

- 08-18 MO, RU. Open up well and blow down 10# tubing and casing; 0# bradenhead. ND wellhead and NU BOP, test. Shut in well and SDFD.
- Safety Meeting. Open up well and blow down 10# casing pressures. TOH and tally 120 joints 2-3/8", 4.7# J-55 tubing, total 3726'. RU A-Plus wireline truck and round-trip 7-5/8" gauge ring to 3551'. Set 7-5/8" PlugWell wireline CIBP at 3551'. TIH with tubing and tag CIBP at 3551'. Pump 150 bbls water down tubing to circulate well clean. Shut in well and SDFD.
- Safety Meeting. Open up well, no pressure. Pump 72 bbls water down tubing to circulate to surface. Pressure test casing to 500# for 10 min, held OK. Plug #1 with CIBP at 3551', spot 97 sxs Class B cement inside casing up to 3119' to isolate PC perforations and to cover up through Ojo Alamo top. Perforate 3 HSC squeeze holes at 1650'. Establish circulation into squeeze holes 1-1/2 bpm at 750#. TIH to 1647' with tubing. Plug #2 with 66 sxs Class B cement spotted in casing, then PUH with tubing to 1000' and squeeze 16 sxs cement outside 7-5/8" casing until it pressured up to 1000#; leave 50 sxs inside casing up to 1438' to cover Nacimiento top. Shut in well with 700# pressure. TOH and WOC. RIH and tag cement at 1450'. Perforate 3 HSC squeeze holes at 371'. Pump 10 bbls water down casing and establish circulation out bradenhead. Plug #3 with 198 sxs Class B cement pumped down 7-5/8" casing from 371' to surface, circulate good cement out bradenhead. Shut in well and WOC. SDFD.
- O8-23 Safety Meeting. Open up well and ND BOP. Dig out and cut off wellhead; had to chip cement. Found cement down 1' in 7-5/8" casing and down 6' in 10-3/4" annulus. Mix 12 sxs Class B cement and install P&A marker. RD and move off. Bryce Hammond, Jicarilla Apache Tribe representative was on location.

#### BLM CONDITIONS OF APPROVAL

The following surface rehabilitation Conditions of Approval must be complied with as applicable, before this well can be approved for final abandonment (see 43 CFR 3162.3-4). Surface rehabilitation work shall be completed within one year of the actual plugging date. Notification for completion of this work can be submitted with a Sundry Notice. Questions? - 1. All fences, production equipment, purchaser's equipment, concrete slabs, deadman (anchors), flowlines, risers, debris and trash must be removed from the location. Non-retrieved flowlines and pipelines will be abandoned in accordance with State Rule 714. Information supporting the non-retrieval will be included in the subsequent report or final abandonment Sundry Notice.
- 2. Production pits will be closed according to the Unlined Surface Impoundment Closure Guidelines, as approved in the Environmental Assessment of December 1993. Any oil stained soils can be remediated on-site according to these guidelines or disposed of in a an approved facility.
- 3. The well pad will be shaped to the natural terrain and left as rough as possible. All compacted areas and areas devoid of vegetation shall be ripped to a minimum of 12" in depth before reseeding.
- 4. Access roads will be shaped to conform to the natural terrain and left as rough as possible to deter vehicle travel. Access will be ripped to a minimum of 12" in depth, water barred and reseeded. All erosion problems created by the development must be corrected prior to acceptance of release. Water bars should be spaced as shown below along the fall line of the slope:

% Slope	Spacing Interval
Less than 20%	200'
2 to 5 %	150'
6 to 9 %	100'
10 to 15 %	50'
Greater than 15%	30'

- 5. All disturbed areas will be seeded with the prescribed certified seed mix (reseeding may be required). Seed mix must be certified weed free to avoid the introduction of noxious weeds. Refer to the original APD for seed mix.
- 6. Notify Surface Managing Agency seven (7) days prior to seeding so that they may be present to witness.
- 7. The period of liability under the bond of record will not be terminated until the well is inspected and the surface rehabilitation approved.

Other Surface Managing Agencies (SMA's) may vary slightly in their restoration requirements. It is your responsibility, as the operator, to obtain surface restoration requirements from other SMA's. We need to be provided with a copy of these requirements. Any problems concerning stipulations received from other SMA's should be brought to us.
