Well very weak, has gas on braden head. Propose to pull 2EUE tubing, clean out to T.D. run casing inspection log. If casing looks good enough to squeeze, we will set cast iron bridge plug near bottom of 5½" pipe and perforate damaged area, and circulate cement as high as possible. Then squeeze. Drill out plug and Frac. W/30,000# sand.

If casing will not stand squeeze job, will run 2½" tubing inside 5½" casing, cement, and recompletes.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
