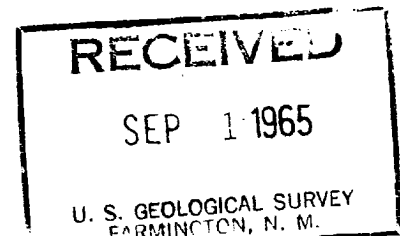

Fractured w/40,000# 20/40 sand, 54,170 gallons water w/250# FR-8 and 51 sacks KCL, Flushed w/5150 gallons water. Injection rate 29.5 BPM, max. pr. 4000#, BDP 750#, treating pressure 4000-3300-3500#. Dropped 3 sets of 8 balls each. ISIP 1700#, 5 min. SIP 1500#.
